#### **AGENDA HEADING:**

Resolution Approving the MLK Brickstone II, L.L.C. Application for Enterprise Zone Benefits for a Housing Project in the City of Des Moines.

## **SYNOPSIS:**

Recommend approval of the application as follows: MLK Brickstone II, L.L.C. (Jack Hatch, Hatch Development Group, 1039 19<sup>th</sup> Street, Des Moines, Iowa 50314) for Enterprise Zone benefits for a \$5.5M project constructing 30 Apartment Units at 1051 19<sup>th</sup> Street in the Drake Park /Sherman Hill/Woodland Heights Enterprise Zone.

#### **FISCAL IMPACT:**

These are State of Iowa tax credits and have no impact on the general fund of the City of Des Moines. All are funded by the State of Iowa Enterprise Zone program

\$ 120,397 Investment Tax Credit; \$ 45,000 Sales Tax Refund

#### **ADDITIONAL INFORMATION:**

The MLK Brickstone, L.L.C. project was originally approved in November 2008 for 54 units to be constructed at this site. The company determined that phasing the project was going to be the most practical decision from an economic standpoint. The project requested an amendment to their original agreement from the Enterprise Zone Commission and Iowa Department of Economic Development (IDED), taking the number of units to 18 for the first phase. The application attached herewith proposes 30 units for Phase II.

The project will offer affordable one and two bedroom units, and be designed to resemble an early 20<sup>th</sup> century row home, with seven brick facades with varying designs. The project will feature geothermal heating and cooling, and offer easy access to downtown, I-235 and Drake University. Construction is anticipated to begin in November 2010 and conclude by December 2011.
