# **ADDITIONAL INFORMATION:**

The City of Des Moines owns a residential property at 1602 Pioneer Road, situated in Pioneer Park. In the past, this residence was used as a Park Superintendent's residence and most recently for a Parks and Recreation intern residence. The Parks and Recreation Department has routinely executed Lease Agreements for this property to generate revenue and defray costs of maintenance of the property. Staff has recently solicited applications for rental of the property after termination of the previous Lease Agreement. Upon review of the applications, staff recommends the approval of a two-year Lease Agreement with Mark Bernard Smith II and Kimberly Irene Smith; the term of the Lease Agreement will begin on May 1, 2010 and expire on April 30, 2012, under the same general terms of the previous Lease Agreements. In addition to the monthly lease revenue, the City will collect a \$1,300 damage security deposit.
