#### **AGENDA HEADING:**

Continued hearing for conveyance of excess City-owned property adjoining 3211 Delaware Avenue to DSDM, LLC for \$14,880.

## **SYNOPSIS:**

Recommend conveyance of City-owned property adjoining 3211 Delaware to DSDM, LLC, Tom Fleming, President, 3211 Delaware Avenue, Des Moines, Iowa 50313-4705, for \$14,880. This action was continued on May 10, 2010, at the request of DSDM, LLC, and is required by Iowa law prior to making a final determination on the proposed sale by resolution. There is no current or anticipated public need for this property.

#### **ADDITIONAL INFORMATION:**

The City of Des Moines is the owner of property located east of 3211 Delaware Avenue. This property was purchased in 1996 for the 7<sup>th</sup> Ward Ditch North of East Hull Avenue Basin Project. DSDM, LLC has requested to purchase a small portion of this property for expansion of their adjoining commercial property at 3211 Delaware Avenue. It has been determined by the City's Public Works – Storm Water Division that this parcel is excess property not needed for the East Hull Avenue Basin.

The size of the property to be conveyed is approximately 17,562 square feet, and is being sold subject to a no-build restriction on the east 187.90 feet. DSDM, LLC has submitted an offer to purchase the above referenced property for \$14,880, which is equal to the estimated restricted use fair market value. The buyer will be required to pay an additional \$5,730 if the no-build restriction is released in the future.
