AGENDA HEADING:

Hearing on application from Pawn America Iowa, LLC for relief from the moratorium to allow pawn businesses at 4620 SE 14th Street and 5730 Douglas / 3709 Merle Hay Road.

SYNOPSIS:

On May 17, 2010 the City Council adopted a temporary moratorium on the establishment of a new or relocation of existing delayed deposit services businesses and pawn businesses pending the comprehensive review of the applicable regulations. The moratorium is in effect until November 9, 2010. Staff is reviewing and preparing recommendations to the Plan and Zoning Commission and City Council regarding whether additional or alternate regulation of delayed deposit services businesses and pawn businesses is needed and what the regulations should be, to prevent or minimize the detrimental impacts of such businesses upon the adjoining and neighboring properties. Since any proposed regulations may impact the locations proposed by Pawn America to varying extents, staff recommends that the City Council uphold the moratorium unless the Council determines that the application of the moratorium is causing the applicant unnecessary hardship.

ADDITIONAL INFORMATION:

Pursuant to Roll Call 10-773 on May 17, 2010, the City Council made the following findings of fact in support of a moratorium on the establishment of new or relocation of existing delayed deposit services businesses and pawn businesses:

- The proliferation of delayed deposit services and businesses (commonly known as "payday lenders") and pawn businesses suggests a commercial corridor and the adjoining neighborhoods are in economic and social decline, negatively impacting reinvestment, economic development efforts and property values along the corridor and the adjoining neighborhoods.
- These businesses do not create much foot traffic for adjacent businesses and a proliferation of them at particular locations can overwhelm a neighborhood and can be a disincentive for the location of other neighborhood businesses in close proximity to them.

- It is reasonable and appropriate to regulate the placement and location of delayed deposit services businesses and pawn businesses so as to avoid the clustering of such businesses and to protect the surrounding neighborhoods from distress and the appearance of commercial districts in decline and to avoid the adverse effects upon the overall business atmosphere of the City, which are likely to result from an over-concentration of such businesses within the commercial corridors.
- A temporary moratorium on the establishment of new or relocation of existing delayed deposit services businesses and pawn businesses is necessary and appropriate to prevent such businesses from locating at sites that are detrimental to the immediate area and the City as a whole, until appropriate regulations can be developed and implemented.
