**AGENDA HEADING:**

Authorization for the City Manager to release mortgage and related security instruments for Abu Abu and Marian Noor, 1439 7th Street, Des Moines, Iowa 50314, 5(h) Affordable Homeownership Program.

**SYNOPSIS:**

Recommend Municipal Housing Governing Board approval for the Des Moines Municipal Housing Agency to reduce the term and release the second mortgage and security instruments for Abu Abu and Marian Noor, 1439 7<sup>th</sup> Street, Des Moines, Iowa 50314.

**FISCAL IMPACT:**

Amount: \$50 processing fee for Second Mortgage term reduction

**ADDITIONAL INFORMATION:**

Abu Abu and Marian Noor have successfully completed the program requirements of the Municipal Housing Agency’s 5(h) Affordable Homeownership Program and requirements for the early forgiveness of the term of the second mortgage. They currently have a seven year forgivable second mortgage in the amount of \$27,060 with the Des Moines Municipal Housing Agency. However, since they have lived in the home for more than seven years and have completed program requirements, City Legal has prepared a Release and Satisfaction of the Second Mortgage and staff is requesting authorization to execute and record the document.
