AGENDA HEADING:

Public hearing to consider approval of the First Amendment to the Operating Agreement and Terminal Lease with United Airlines, Inc. at the Des Moines International Airport.

SYNOPSIS:

Public hearing for approval of the First Amendment to the Operating Agreement and Terminal Lease with United Airlines, Inc.

FISCAL IMPACT:

<u>Amount:</u> This agreement will follow the same rates and charges formula (paying aircraft landing fees and apron costs) as those similar agreements previously approved by the Council with other airlines operating at the airport. Because United Airlines participates in airfield and terminal cost-sharing as a signatory carrier, any added operations and passengers from their activity will reduce costs to the other signatory carriers; however, the exact amount is to be determined.

Additionally, United Airlines will amend their current lease of office and counter space in the airport terminal building. The total amount of exclusive space will be 5,097 sq. ft. which, using current rates, results in an annual rent of \$136,440.

ADDITIONAL INFORMATION:

United Airlines recently requested an additional 410 square feet of second floor office space in the main terminal building for their local manager, as well as 966 square feet of maintenance and storage space on the main level of the Terminal Concourse. The space was previously unoccupied.

The Airport Board has recommended that Council approve the Amendment.
