AGENDA HEADING:

Submitting 2010 Prairie Meadows Community Betterment Grant Application.

SYNOPSIS:

Recommend approval of a grant application to Prairie Meadows Racetrack and Casino to provide specialized training and equipment for the Police Mounted Patrol Program.

FISCAL IMPACT:

Amount: \$12,000

Funding Source: GE001, POL100125, Recommended Budget June 30, 2011, page 241

No local match is required. This is a twelve month grant beginning January 1, 2011 and closing

December 31, 2011.

ADDITIONAL INFORMATION:

The Mounted Patrol Unit, which began in 1998, uses high visibility to provide citizens a sense of personal safety especially in areas where a vehicle would not be able to travel. The police officers receive specialized training every year to update and maintain special skills of law enforcement from horseback. The officers have the advantage of being elevated to observe activities in crowded areas and the citizens have the marked advantage of being able to locate an Officer easily. Citizens of all ages are attracted to the horses thus giving citizens and Officers the opportunity to form and maintain positive relationships within the community.

The requested funds will ensure the officers receive the specialized training and equipment, boots, and pants needed to perform these special duties. The cost of veterinary services required for special events is requested. Also requested are funds for a display cabinet in the Police Museum and coloring books to be handed out at neighborhood and special events to promote a positive relation between the Police Department and the community
