AGENDA HEADING:

Approval of Supportive Housing Program (SHP) and Shelter Plus Care Renewal Grant Agreements with the United States Department of Housing and Urban Development (HUD).

SYNOPSIS:

Recommend approval of SHP and Shelter Plus Care Renewal Grant Agreements with HUD and authorizing the Mayor to execute such agreements.

FISCAL IMPACT:

Amount: Three 2009 SHP renewal grants totaling \$625,073, and one Shelter Plus Care Renewal grant for \$1,070,424.

Funding Source: U.S. Department of HUD; No City Impact

ADDITIONAL INFORMATION:

On October 26, 2009, by Roll Call No. 09-1923, the City Council approved the 2009 Continuum of Care application as recommended by the Polk County Housing Continuum Board and the City Manager and authorized and directed the City Manager to submit the application to the U.S. Department of HUD. Included in the application were SHP renewals for \$287,355 to fund the Iowa Homeless Youth Center's Lighthouse Host Home for transitional housing; \$110,250 for the Iowa Institute for Community Alliances to operate the Homeless Management Information System; and \$227,468 to fund the House of Mercy at Capital Park's transitional housing program for women and children. Also included in the application was \$1,070,424 of Shelter Plus Care funding for the Anawim Housing Program
