AGENDA HEADING:

Communication from the Chair of the Polk County Housing Continuum (PCHC) Board recommending that the City Council adopt the Board's recommendations for the 2010 Supportive Housing Program (SHP) priorities and procedures.

SYNOPSIS:

This action adopts the priorities and procedures for development of the City's 2010 Supportive Housing Program (SHP) application, as recommended by the PCHC Board and the City Manager.

FISCAL IMPACT:

Amount: \$1,671,932

Funding Source: 2010 HUD Supportive Housing Program

ADDITIONAL INFORMATION

The City Manager recommends that the City Council adopt the priorities and procedures as outlined in the communication from the PCHC Board Chair. The funding is currently estimated at \$1,671,932 for SHP projects and over \$1,000,000 for the Shelter Plus Care Program, which is part of the same NOFA. The NOFA has not been published as of this date and the application historically has been due within 45 days after publication. As stated in the PCHC Board Chair's communication, because of the tight time frame for development and submission of the application, the SHP Committee has accepted applications for the program and is currently reviewing them.

Additionally, at their meeting on September 7, 2010, the Housing Coordinating Council heard a presentation on the Polk County Housing Continuum's recommendations for priorities and procedures for developing the 2010 SHP/ Shelter Plus Care application and approved a resolution to support the PCHC's recommendations.
