## **AGENDA HEADING:**

Approving reassignment of SCRUB waste services to Waste Management, Inc. due to Waste Management, Inc. purchasing Artistic Waste in 2010.

## **SYNOPSIS:**

In 2010, the City requested bids from waste services companies for roll-off services at Spring Cleanup to Remove Urban Blight (SCRUB) events. The contract was for one year with two renewals. Artistic Waste Services, Inc. was awarded the contract as the lowest bidder. In May 2010, Waste Management purchased Artistic Waste Services. Therefore, staff recommends reassignment of the contract with Artistic Waste Services to Waste Management, Inc.

### **FISCAL IMPACT:**

Amount: No change. Annual amount remains at \$40,000.

#### **ADDITIONAL INFORMATION:**

In spring 2010, the City requested bids from waste service companies to provide waste services at SCRUB events for calendar year 2010. Artistic Waste Services, Inc. was the lowest bidder and awarded the contract for the 2010 SCRUB events with two optional renewals. In 2010, Waste Management, Inc. purchased Artistic Waste Services.

The agreement for SCRUB waste services should be reassigned, according to the City's Procurement Officer, to Waste Management, Inc. The agreement prices will remain in effect through the 2010 SCRUB season.
