AGENDA HEADING:

2010 COPS Secure Our Schools Grant Award Approval

SYNOPSIS:

Through the U.S. Department of Justice, the City of Des Moines has been awarded a COPS Secure Our Schools Grant in the amount of \$100,000. Council approval is required to authorize the Mayor and Chief of Police to sign and accept the award. The funding will bring state of the art security systems to Des Moines schools. The systems would include card entry readers, exterior security lighting, security cameras and double cylinder locks to Elementary, Middle, and High Schools in the City of Des Moines

FISCAL IMPACT:

This project is estimated to cost \$200,000. The grant will fund up to 50% of the total cost to implement the program. The School District has agreed to provide the rest of the funding with the Police Department responsible for the administration of the grant. The grant is for a two-year period from 09-01-2010 through 08-31-2012.

ADDITIONAL INFORMATION:

At the June 28, 2010 Council Meeting under Roll Call No. 10-1032, Council Communication No. 10-417, Item 21, Council approved a \$200,000 grant application through the Department of Justice, Community Oriented Policing Services (COPS) office, 2010 COPS Secure Our Schools Grant program to request funding which would bring state of the art security systems to Des Moines Schools.
