ADDITIONAL INFORMATION:

Misti Allison, (NR-0), Sergeant, to Las Vegas, NV, from November 28 – December 5, 2010, (\$1,739), to attend a conference sponsored by the National Internal Affairs Investigators Association. Training will be received in the high liability areas of use of force, interview strategies, investigations of citizen complaints, Internal Affairs procedures, investigation of critical incidents, and liability management.

T.M. Franklin Cownie, (R-4), Mayor, to Sundance, UT, from November 7 – November 9, 2010, (\$391), to attend the Green Schools Summit. The Summit will bring Mayors and Superintendents from 12 cities around America to engage in two days of learning, dialogue, and shaping actions that will address the importance and various challenges of greening America's schools. Green schools will provide significant and immediate health, learning, and community benefits for children, parents, teachers, and faculty. The City will be reimbursed for airfare.

David Seybert, (NR-0), Sergeant, to Las Vegas, NV, from December 5 – December 10, 2010, (\$1,542), to participate in a course offered by the Las Vegas Metro Police Department. The course is directed towards Internal Affairs Investigators and focuses on Administrative, Criminal, and Legal Aspects of Use of Deadly Force, and Officer Involved Shootings.

The budget for travel and training in Fiscal Year (FY) 2011 is \$621,718. The amount expended for travel and training in FY 2010, as of October 18, 2010, is \$91,993.
