AGENDA HEADING:

Approving and Authorizing the Execution of Iowa Jobs Program Grant Award Agreement with the Iowa Jobs Board and the Iowa Finance Authority for \$2,100,000 for the Central Place Levee Repair.

SYNOPSIS:

Recommend approval and authorization to execute Iowa Jobs Program Grant Award Agreement with the Iowa Jobs Board and the Iowa Finance Authority (IFA) for the Central Place Levee Repair. On September 15, 2010, Governor Culver announced that the City of Des Moines had been awarded an I-Jobs grant in the amount not to exceed \$2,100,000 for the Central Place Levee Repair project.

FISCAL IMPACT:

Amount: \$7,631,998

Funding Source: Various funding sources, as follows:

- \$2,100,000 I-Jobs Grant
- \$4,960,799 Federal share from Appropriations through the U.S. Army Corps of Engineers
- \$571,199 2010-11 CIP, Page Storm Water Improvements 10, Flood Protection System Improvements, FLD008, Storm Revenue Bonds

ADDITIONAL INFORMATION:

City Council authorized submittal of the Central Place Levee Repair project on July 27, 2009, by Roll Call 09-1395 and June 28, 2010, by Roll Call 10-1022. The I-Job applications were for \$2,100,000 of the estimated \$4,200,000 construction cost. On September 15, 2010, Governor Culver announced that the City of Des Moines had been awarded an I-Jobs grant in the amount not to exceed \$2,100,000 for the Central Place Levee Repair. The Grant Award Agreement has been drafted by the Iowa Finance Authority staff.

On June 28, 2010, by Roll Call 10-1020, City Council approved the Project Partnership Agreement (PPA) with the Corps of Engineers for construction of the Central Place levee improvements. The PPA makes the City responsible for 35% of the flood damage reduction project costs. Funding provided to date, as well as eligible City costs, will be credited towards the City's share. A portion of the City responsibility will be paid using the I-Jobs funding.

The Corps of Engineers accepted bids on the Central Place levee reconstruction on September 2, 2010.

There were six bidders. The Corps of Engineers awarded the construction contract to Reilly Construction Co, Inc. with a low bid of \$5,398,290. Construction is expected to begin in early 2011.
