# **AGENDA HEADING:**

Approving Supplemental Agreement No. 1 to the 2011 Sewer Repair Contract 1 professional services agreement with Foth Infrastructure and Environment, LLC, for design and construction phase services, not to exceed \$56,490.

### **SYNOPSIS:**

Recommend approval of Supplemental Agreement No. 1 to the 2011 Sewer Repair Contract 1 professional services agreement with Foth Infrastructure and Environment, LLC (Douglas Ernst, Senior Project Manager, 8191 Birchwood Court, Suite L, Johnston, IA), for a total cost not to exceed \$56,490, based on hourly rates, to provide design and construction phase services for the 2011 Sewer Repair Contract 1.

### **FISCAL IMPACT:**

Amount: \$56,490

<u>Funding Source</u>: 2011-2012 CIP, Page Storm Water Improvements – 4, City-wide Storm Water Utility Projects, Storm Revenue Bonds, partial reimbursement from FEMA Public Assistance Grant.

# **ADDITIONAL INFORMATION:**

On May 23<sup>rd</sup>, 2011 by Roll Call 11-0871 Council approved a professional services agreement with Foth Infrastructure and Environment, LLC to perform design and construction phases services for 2011 Sewer Repair Contract 1. Subsequently sewer repairs have been identified to be required at additional locations which were not in the original design contract. Those repairs include a sanitary and storm sewer repair near Greenwood Terrace, a sanitary sewer creek crossing near 1646 E Park Avenue, and a storm sewer repair on E Pine Avenue. The type of sewer repairs are similar in nature to those already included in the original contract. In order to expedite the design process, staff from Public Works and Engineering selected Foth Infrastructure and Environment, LLC to perform the engineering services. Supplemental Agreement No. 1 has been negotiated with Foth Infrastructure and Environment, LLC for a total cost not to exceed \$56,490, based on hourly rates, to provide design and construction phase services.
