#### **AGENDA HEADING:**

Approving contract and bond for construction of an improvement the estimated cost of which is less than the Iowa Code competitive bid threshold, 3021 Deep Woods Court Sanitary Sewer Repair, Drake Construction, LC, Ronald Drake, Manager, \$58,385.

Recommend receive and file bids, designate lowest bidder, approve contract and bond, and permission to sublet for 3021 Deep Woods Court Sanitary Sewer Repair, 07-2011-010.

# ADDITIONAL INFORMATION:

Sections 26.3 and 26.12 of the Code of Iowa exempt the governing body from advertisement for sealed bids and holding a public hearing on the proposed plans, specifications, form of contract and estimated cost of the improvement when the Engineer's estimated cost for the improvement is less than the competitive bid threshold (currently \$100,000 for this type of work) established in Section 314.1B.

The Engineering Department has prepared plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate for the construction of the following improvement:

3021 Deep Woods Court Sanitary Sewer Repair, 07-2011-010

The improvement includes placing sheet piling and rip rap, earthwork, sanitary sewer repair and restoration; all in accordance with the contract documents, including Plan File Nos. 527-128/130 at 3021 Deep Woods Court, located in the City of Des Moines, Iowa.

Said plans and specifications were issued to contractors that normally bid on City of Des Moines projects of a similar nature, as part of a solicitation for proposals for said improvement; requesting the contractors to submit proposals to the Des Moines City Engineer on or before 11:00 a.m. on February 28, 2011.
