AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Army Post Road and Indianola Avenue Culvert Extension Professional Services Agreement with Foth Infrastructure and Environment, LLC, for design and construction phase services for modification to the design to comply with United States Army Corps of Engineers permit requirements, not to exceed \$26,250.

SYNOPSIS:

Recommend Council approval of Supplemental Agreement No. 1 to the Professional Services Agreement with Foth Infrastructure and Environment, LLC, Douglas Ernst, Senior Project Manager, 8191 Birchwood Court, Suite L, Johnston, Iowa 50131, for a total cost not to exceed \$26,250, based on hourly rates, to provide design and construction phase services for modification to the design to comply with United States Army Corps of Engineers permit requirements.

ADDITIONAL INFORMATION:

The United States Army Corps of Engineers (Corps) has determined that the Army Post Road and Indianola Avenue Culvert Extension project is located within a Waters of the United States (WUS). In order for the Corps to issue the necessary permit, stream mitigation will be required. City staff will be working with the design consultant to determine what stream mitigation proposals will be submitted to the Corps for review and approval.

Supplemental Agreement No. 1 includes additional design surveys, construction phase and environmental services, and permanent easement plats to comply with the Corps' stream mitigation requirements.
