AGENDA HEADING:

Approving Change Order No. 1 with Strong Tower Construction, LLC dba Koch Corporation for additional work on the City Hall Window Replacement for a total not to exceed \$61,264.

SYNOPSIS:

Recommend approval of Change Order No. 1 in an amount not to exceed \$61,264 with Strong Tower Construction, LLC d/b/a Koch Corporation, Benjamin Feinn, CEO, 1131 Logan Street, Louisville KY, 49204, for additional work on the City Hall Window Replacement to remove asbestos around the window frames.

ADDITIONAL INFORMATION:

On February 14, 2011, under Roll Call No. 11-0258, the City Council awarded the City Hall Window Replacement contract to Strong Tower Construction, LLC, d/b/a Koch Corporation in the amount of \$421,414, which was 29.17% below the Engineer's estimate. The improvement includes removal of a portion of the existing exterior aluminum framed windows and installation of new thermally-broken aluminum framed windows with 1" insulating glass.

The windows were tested last fall for asbestos. The results showed small amounts on the exterior of the windows. Therefore, the original plan for removal of asbestos containing sealants was to have an independent hazardous materials contractor remove all hazardous materials prior to the installation of the replacement windows. During the process of preparing for asbestos removal by the independent contractor, it was discovered that there were additional locations of compounds containing asbestos that could not be removed before window installation. These compounds were located within the frame assembly of the existing window system. It was therefore determined to be less expensive and less disruptive to office work areas to have Koch Corporation submit a proposal to abate all asbestos containing materials as a component of the window replacement process. This work will be eligible under the energy grant.
