

# **ADDITIONAL INFORMATION:**

This 10-foot-wide concrete trail will be approximately 750 feet long. While this is a short trail segment, it is a critical link in the overall system, connecting to the extent of the Des Moines and West Des Moines trail systems and completing a continuous trail route between downtown and the westernmost parts of West Des Moines. Two permanent easements and one temporary easement will be needed for this project. Relocation assistance will not be required
