# **ADDITIONAL INFORMATION:**

On February 28, 2011, by Roll Call Number 11-0367, City Council approved plans, specifications, form of contract documents, Engineer's estimate and designated lowest responsible bidder as Dean Snyder Construction Co. in the amount of \$8,130,000 for the Fire Department Training and Logistics Facility. Materials testing by the owner is required in the technical specifications. Special inspections and testing are required by building code and are necessary to ensure proper construction of the project.

A Request for Proposals (RFP) for these testing services was sent to several consultants and posted on the City's website. Five proposals were received in response to the RFP. A selection committee rated the proposals and selected Terracon Consultants based on their qualifications, technical approach to this project and past experience with the soils on the site.
