#### **AGENDA HEADING:**

Authorizing Agreement for Preliminary Engineering Services between the City of Des Moines and Norfolk Southern Railway Company for the SE Connector – Relocation of Norfolk Southern tracks.

## **SYNOPSIS:**

Recommend approval of the Agreement for Preliminary Engineering Services between the City of Des Moines and Norfolk Southern Railway Company for the relocation of the Norfolk Southern tracks in the vicinity of SE 14th Street

## **FISCAL IMPACT:**

Amount: \$50,000

<u>Funding Source</u>: 2011-2012 CIP, Page Street Improvements - 35, STR219, Southeast Connector – SE 6th Street to SE 14th Street.

# **ADDITIONAL INFORMATION:**

The preferred alternative for the Southeast Connector included a major at-grade rail crossing with the Norfolk Southern Railway as the roadway crosses under the SE 14th Street viaduct. As the rail crossing was being negotiated with the Norfolk Southern Railway Company, additional alternatives were discussed that would eliminate the at-grade rail crossing, resulting in a major improvement for both the Southeast Connector and the railroad. By re-locating the rail line to nearby abandoned rail corridors, the railroad is able to continue serving their current customers and eliminate the liability of adding crossings of the Southeast Connector, SE 15th Street and the trail.

The relocation of the railroad can be accomplished at approximately the same overall construction costs, but will eliminate the operation and maintenance and long term liability of the crossings. The Southeast Connector construction schedule will be modified to accommodate the railway design and construction process. The new schedule includes beginning work in 2012 and completion in late 2013. The schedule is tied to the railroad relocation by Norfolk Southern.
