AGENDA HEADING:

Hearing on Grandview Golf Course Clubhouse: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids.

SYNOPSIS:

This is a public hearing to allow for public input on the Grandview Golf Course Clubhouse and to take the necessary actions, as required by Iowa Code, to authorize a contract for construction of the proposed project. The existing clubhouse at Grandview Golf Course is deteriorating and in need of replacement. The new clubhouse includes a pro shop, snack shop, commercial kitchen, offices, a new banquet and meeting room space.

ADDITIONAL INFORMATION:

On March 14, 2011, under Roll Call No. 11-0419, the City Council received and filed plans, specifications, form of contract documents and City Engineer's estimate for the construction of the Grandview Golf Course Clubhouse. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, form of contract documents and engineer's estimate for the construction of the Grandview Golf Course Clubhouse, 11-2009-009. The improvement includes construction of a 6,000 square foot clubhouse for the Grandview Golf Course that is steel frame with metal stud infill construction, which includes a pro shop, snack bar, full commercial kitchen, multipurpose room, and a 100 car parking lot to the north; all work in accordance with the contract documents including Plan File Nos. 511-001/069, at 2401 E. 29th Street, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

CPMI Construction, L.C., Des Moines, IA Pro Commercial, LLC, Huxley, IA Breiholz Construction Co., Des Moines, IA Dean Snyder Construction Co., Ankeny, IA Betts & Beer Construction, Adair, IA Larson & Larson Construction LLC, Urbandale, IA Jensen Builders Ltd., Ames, Iowa Rochon Corporation of Iowa, Inc., Urbandale, IA Edge Commercial, LLC, Waukee, IA – Bid not read

The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on April 12, 2011.

The bids received for the Base Bid #1 and for Alternate #1 were greater than the Engineer's estimate. The funding sources are specific to Base Bid #1, Base Bid #2 and Alternate #1. A new breakout must be made prior to designating lowest responsive, responsible bidder and approving contract and bond and permission to sublet. There are potential issues on the proposal of the apparent low bidder which must be resolved prior to designating lowest responsive, responsible bidder. It is anticipated the contract will be brought before the City Council on May 9, 2011, for award.
