### **AGENDA HEADING:**

Approval of tax abatement applications for improvements to a property located at 1900 SE 6th Street; South View Senior Apartments was recently completed on the site.

### **SYNOPSIS:**

Approval of the application to apply prospectively, as provided by Iowa law. The application was filed with the City of Des Moines prior to February 1, 2011, but was inadvertently omitted from the approval list submitted to City Council on February 28, 2011.

### **FISCAL IMPACT:**

Amount: Tax abatement upon property with a claimed value of \$4,500,000.

<u>Funding Source</u>: Taxes are generated in the first year from the land value but the improvement value will be forthcoming when the \$4,500,000 comes on the tax rolls after abatement ends.

### **ADDITIONAL INFORMATION:**

The applicant chose Schedule 4A with an estimated value of \$4,500,000. Schedule 4A is for qualified real estate in specific areas generally located downtown or near the downtown area. The exemption period is 10 years and the exemption amount is 100% of the actual value added by improvements.
