AGENDA HEADING:

Approving City of Des Moines Municipal Housing Agency submittal of the Public Housing Family Self Sufficiency Program Coordinator grant application to the U.S. Department of Housing and Urban Development.

SYNOPSIS:

Recommending Municipal Housing Governing Board approval of submittal of the Public Housing Family Self-Sufficiency Program Coordinator grant to the U.S. Department of Housing and Urban Development (HUD) and authorization for the Mayor to execute and the Executive Director of DMMHA to implement the grant if awarded.

FISCAL IMPACT:

Amount: \$32,024

ADDITIONAL INFORMATION:

The City of Des Moines Municipal Housing Agency (DMMHA) currently receives funding from HUD for a part time program coordinator to administer a Public Housing Family Self-Sufficiency Program (FSS) for Public Housing residents.

The FSS program coordinator provides individual case management to assist FSS program residents in achieving goals to become self-sufficient. FSS Coordinators provide training, education, and job development skills to enrolled residents. The FSS Coordinator currently provides case management services to 25 Public Housing FSS program participants. This number will increase to 30 Public Housing FSS program participants in July 2011.

Funds are available through HUD to renew the fiscal year 2010 grant. The grant will cover 50% of the salary and fringe benefits for one full-time program coordinator. The remainder of the salary and fringe benefits are paid from a Section 8 FSS Coordinator grant for the Coordinator's work with the Section 8 FSS program.
