Darlene Blake, (R-0), Sister City Commission Member – Cultural Affairs, to Stavropol City, Russia, from June 26 – July 3, 2011, (\$1,257), as a member of Des Moines' Sister City delegation. Trip will enhance international relations across the government sector.

Lawrence McDowell, (R-0), Deputy City Attorney, to Chicago, IL, from September 10 – September 14, 2011, (\$2,500), to attend the International Municipal Lawyers Association Annual Meeting Conference. The conference includes sessions on various topics that will be useful to the City of Des Moines, including land use, municipal finance, tax increment financing, redistricting, personnel/employment and litigation.

Eric Nevins, (R-0), Communications Supervisor, to Philadelphia, PA, from August 4 – August 10, 2011, (\$1,883.84), to attend the annual meeting of the Association of Public Safety Officials. Nevins will be present at the Executive Council meeting as the Iowa Chapter representative and will also attend seminars and courses on different aspects of public safety communications technology.

Kerri Przybylski (NR-0), Engineer, to Glenview, IL, from July 31 – August 6, 2011, (\$1,302), to attend the Peer Fitness Trainer Certification Program. The class will provide employees with the tools to become a Peer Fitness Trainer, which will provide skills required to implement a department fitness program, improve the wellness of fire fighters and design a physical training program for new recruits.

Vidal Spaine, (R-0), Sister City Commission Member – Stavropol Chair, to Stavropol City, Russia, from June 26 – July 3, 2011, (\$3,231), as a member of Des Moines' Sister City delegation. Trip will enhance international relations across the government sector.
