#### **AGENDA HEADING:**

Hearing on 2011 Sidewalk Replacement Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids and designating lowest responsible bidder as T K Concrete Inc., Tony J. VerMeer, President, 1608 Fifield Road, Pella, Iowa 50219, \$265,725.

### **SYNOPSIS:**

This is a public hearing to allow for input on the 2011 Sidewalk Replacement Program and to take the necessary actions, as required by Iowa Code, to authorize a contract for construction of the proposed project. This project provides for a city-wide program to replace deteriorated City sidewalks, sidewalks damaged by City activities or by City trees in the parking area and sidewalks for residents that qualify for special assessment subsidy.

### **FISCAL IMPACT:**

Amount: \$265,725 Construction Contract (\$299,150 City Engineer's Estimate)

<u>Funding Source</u>: 2011-2012 CIP, Sidewalk Replacement, STR084, G. O. Bonds, Page Street – 30.

### **ADDITIONAL INFORMATION:**

On May 9, 2011, under Roll Call No. 11-0768, the City Council received and filed plans, specifications, form of contract documents and City Engineer's estimate for the construction of the 2011 Sidewalk Replacement Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, form of contract documents and engineer's estimate for the construction of the 2011 Sidewalk Replacement Program, 09-2011-003. The improvement includes reconstruction of Class A and Class B Portland cement concrete sidewalks four inches thick, six inches thick at driveways, together with all appurtenances; in accordance with the contract documents at various locations city-wide in Des Moines, Iowa. Sidewalks will be replaced at locations inspected by the Public Works Department. Handicapped accessible ramps will also be constructed in the vicinity where sidewalks will be replaced.

Sealed bids for said improvement were submitted by the following bidders:

T K Concrete Inc., Pella, IA Ti-Zack Concrete, Inc., Le Center, MN

The bids were received and opened at a public meeting presided over by the City Engineer in the City

Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on May 24, 2011.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by T K Concrete Inc., in the amount of \$265,725, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement, as stated above.
