AGENDA HEADING:

Request City’s Purchasing Division to issue a blanket purchase order for CrafcO pavement crack sealant (Roadsaver 221) and detackifier (Detack) to be purchased during fiscal year 2012

SYNOPSIS:

Recommend approval for City’s Purchasing Agent to issue a blanket purchase order for CrafcO pavement crack sealant and detackifier to Logan Contractors Supply (Bruce Logan, President, 4101 106th St., Urbandale, IA 50322), the sole area-wide distributor

FISCAL IMPACT:

Amount: \$55,000

Funding Source: PWK990000/STR102, Capital Projects/Concrete Paving Restoration, Street Improvements – 8.

ADDITIONAL INFORMATION:

The Department of Public Works utilizes a CrafcO SS125 Sealant Melter/Applicator extensively in its pavement maintenance program to seal cracks that develop in the pavement, thereby extending the pavement life. CrafcO sealant is required to use in the CrafcO Melter/Applicator. Municipal Code section 2-726 (a) (7) provides for a non-competitive procurement of materials when the required materials are available only from a single area-wide distributor and competitive bids for such materials are thus not reasonably attainable.
