## AGENDA HEADING:

Approval to award contracts to AllMed, Bound Tree, Midwest Medical Supply, and Henry Schein to furnish 246 medical and pharmaceutical supplies to be used by the Fire Department.

## SYNOPSIS:

Recommend approval of bids received from Alliance Medical Inc (dba AllMed), 4715 Scruggs Station Road, Jefferson City, MO 65109 CEO – Larry Dahl; Bound Tree Medical, 5000 Tuttle Crossing Blvd Dublin, OH 40316 CEO – Hank Struik; Henry Schein, PO Box 3227, Irmo, SC 29063, CEO – Stan Bergman; Midwest Medical Supply, 13400 Lakefront Dr, Earth City, MO 63045, CEO – Gary Reeve (14 bids mailed, 5 received).

## FISCAL IMPACT:

Amount: \$195,000

Funding Source: FY2012 Operating Budget FIR041000 532160, Fire - Emergency Medical Services, Medical And Laboratory.

## ADDITIONAL INFORMATION:

Each of the vendors being recommended provided the majority of the 246 items requested. A bid received from Kreisers, Inc., 1723 Geneva St, Sioux City, IA 51103, CEO – Dave Larson included bids for only 24 items, of which only 2 were individually low bids, saving \$0.82 per item. The savings to the City for a year would be less than \$100.00; however, the Fire Department rejects this bid because administrative cost of the contract will exceed any potential savings. Additionally, the recommended vendors will achieve the lowest possible costs for 244 of the 246 bid items.
