AGENDA HEADING:

Ordering construction of the following: Demolition at 717 Grand Avenue former YWCA - Receiving bids, (7-26-11), and Setting date of hearing, (8-8-11). (Construction Estimate - \$1,445,000).

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. The project includes the above grade demolition of the former YWCA building.

FISCAL IMPACT:

Amount: \$1,445,000 City Engineer's Estimate

<u>Funding Source</u>: 2011 Operating Budget, Page 56, YWCA Acquisition, SP743, CMO980717, OPR187, Being: Economic Development Enterprise Account to be reimbursed with Tax Increment Funds (TIF) generated by the Downtown TIF District.

ADDITIONAL INFORMATION:

The project scope and design has been modified for rebidding, to reflect the lower level of the structure to remain in-place and only the upper level of the structure to be removed.

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Demolition at 717 Grand Avenue former YWCA, 25-2011-006. The improvement includes demolition of the former YWCA at 717 Grand Avenue, Des Moines, Iowa, protection of the existing skywalk structures which will remain in place, site clearance with the lower level of the building structure to remain in place, and disconnection of select utilities; all in accordance with the contract documents including Plan File Nos. 533-169/184.

The estimated construction cost is \$1,445,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
