AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement with HDR Engineering, Inc., to perform additional design and construction phase services for the Tonawanda Drive Ravines Improvements project, not to exceed \$125,731.

SYNOPSIS:

Recommend Council approval of Supplemental Agreement No. 1 to the Professional Services Agreement with HDR Engineering, Inc, Ronald J. Sova, Vice President, 8404 Indian Hills Drive, Omaha, Nebraska, for a total cost not to exceed \$125,731, based on hourly rates, to provide additional design and construction phase services for the Tonawanda Drive Ravine Improvement project.

ADDITIONAL INFORMATION:

On July 12, 2010, by Roll Call 10-1119, the City Council approved a professional services agreement with HDR Engineering, Inc. for design services related to the Tonawanda Drive Ravines Improvement project. Staff has negotiated Supplemental Agreement No. 1 for a total cost not to exceed \$125,731, based on hourly rates, to provide additional design services related to utility conflict coordination, traffic control, and road resurfacing, as well as construction phase services.

As part of the Tonawanda Ravines Improvement Study consultant selection process in 2008, staff received proposals from six firms. A selection committee composed of City of Des Moines staff reviewed the proposals and recommended selection of HDR Engineering, Inc, based on their qualifications and experience.
