AGENDA HEADING:

Extension of the temporary moratorium on new gas stations in the C-3 and C-3A zoning districts until October 11, 2011.

SYNOPSIS:

Community Development and Legal staff are working to prepare ordinances for consideration by the Plan and Zoning Commission and City Council. Staff recommends that the temporary moratorium be extended to at least October 11, 2011 in order to accommodate code drafting, public information meetings, public hearing by P&Z, and public hearing and at least first reading by the City Council.

ADDITIONAL INFORMATION:

After a comprehensive review of the "What's Next Downtown" plan, Staff believes that c-stores and other auto-dominant uses should be allowed in the downtown. However, the location of auto-dominant uses and design of all uses within the downtown should be regulated based upon the vision of the "What's Next Downtown Plan" that was adopted by the City Council on March 10, 2008.

A preliminary summary of proposed regulations includes the following:

- Continue to allow c-stores w/ fuel sales in C-3 and C-3A districts.
- Eliminate the following uses in C-3 and C-3A districts:
 - Lumberyards and building material sales yards
 - Manufacturing, packaging and storage of dairy products
 - Trailer, boat, and farm implement establishments for display, hire, rental and sales
 - Drive in theaters
 - Monument sales yards
 - Motels, motor hotels, and tourist courts

- Auction businesses
- Sign painting shops
- Mobile Home Parks
- Adult entertainment businesses
- Create a Downtown Overlay District as follows:
 - District boundaries of I-235 on north, MLK on west, SE14 on east, Raccoon and DM Rivers on the south.
 - P&Z review of all site plans within the district. Appeals any decision by P&Z may be made by the applicant to City Council.
- Establish Design Guidelines for the Downtown Overlay District as follows:
 - Prohibit c-stores and other auto-dominant uses (fast food drive-thru facilities, etc.) from fronting gas canopies, drive-up lanes and parking along any "pedestrian corridor" as designated in the "What's Next Downtown" plan.
 - Prohibit auto-dominant uses and limit other uses from having vehicular access drives from any "pedestrian corridor".
 - Prohibit stand-alone auto-dominant uses within the overlay district. Such uses must be part of a commercial center with unified design.
 - Require sites greater than 2 acres to be submitted as a Planned Unit Development.
 - Require parking ramps to include ground floor retail or be designed for conversion to ground floor retail.
 - Limit the number of fuel pumps/vehicles that can be fueled at one time to 4 6 pumps (8-12 vehicles).
 - Require buildings to be a minimum 3-stories or 36' whichever is less and utilize building massing identified in "What's Next Downtown Plan" for guidance when reviewing requests to vary from the guideline.
 - Require 70% of block to be fronted by a building along a principal street.
 - Require 70% of building frontage to be within 1-foot of the front lot line.
 - Require C-3 landscape standards for entire area.
 - Require use of black archetype light poles and fixtures.

- Prohibit outside storage.

Community Development and Legal staff are working to prepare the above regulations for consideration by the Plan and Zoning Commission and City Council. The following schedule is proposed:
