AGENDA HEADING:

Hearing on City-wide Fixed Time Traffic Signal Upgrade: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Iowa Signal Inc., Wayne Lesley, President, \$475,108.53.

SYNOPSIS:

This is a public hearing to allow for public input on the City-wide Fixed Time Traffic Signal Upgrade and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project consists of upgrading the traffic signal operation at twenty-one existing intersections that currently operate as fixed time signals. The project includes the installation of vehicle detectors on the side streets and left-turning phases, along with adding pedestrian push buttons, thereby maximizing the amount of green time available for the major roadways.

FISCAL IMPACT:

Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the City-wide Fixed Time Traffic Signal Upgrade, 04-2011-002. The improvement includes the upgrading of existing signals and installation of detectors at various locations; all in accordance with the contract documents, including Plan File Nos. 530-001/021, at the following locations within the City of Des Moines, Iowa:
