AGENDA HEADING:

Approving Change Order No. 3 with H & W Contracting, LLC for additional work on the Court Avenue & Water Street Sewer Separation, for a total not to exceed \$120,395.

SYNOPSIS:

Recommend approval of Change Order No. 3, in an amount not to exceed \$120,395, with H & W Contracting, LLC, Thomas L. Hurd, President, 3416 West Hovland Avenue, Sioux Falls, SD, 57107, for additional work on the Court Avenue & Water Street Sewer Separation to line the 60 inch sanitary sewer in Walnut Street.

FISCAL IMPACT:

Amount: \$120,395

<u>Funding Source</u>: 2011-2012 CIP, Court Avenue/Water Street Sewer Separation, STE081, Page Storm-6, with a transfer of \$120,395 from Lining Sanitary Trunk and Lateral Sewers, Sanitary Sewer Funds, SAE049, Page Sanitary-13.

ADDITIONAL INFORMATION:

This project involves constructing a storm sewer along Court Avenue from Water Street to 2nd Avenue, then north along 2nd Avenue from Court Avenue to Grand Avenue, and along Grand Avenue from 2nd Avenue to 3rd Street. The current plan to install storm sewer along 2nd Avenue involves boring a 54 inch diameter sewer under Walnut Street. Boring the sewer under Walnut Street will reduce the traffic impacts and eliminate a conflict with the 60 inch sanitary sewer. The Contractor constructing the Court Avenue & Water Street Storm Water Pump Station also bored under a 60 inch sanitary sewer. During the boring operation, the brick sewer collapsed, causing delays to the project and additional emergency sewer repairs. Therefore, staff is recommending a proactive approach to line the 60 inch sanitary sewer along Walnut Street to avoid a potential for the sewer to collapse, since the sewer condition is worse than originally anticipated.
