AGENDA HEADING:

Approving Greater Des Moines Partnership – Partnership 2012 Investment Campaign Commitment.

SYNOPSIS:

To approve payment of \$100,000 as part of the Greater Des Moines Partnership – Partnership 2012 Investment Campaign.

FISCAL IMPACT:

Amount: \$100,000

Funding Source: SP743 CMO980717 City Manager – Economic Development Enterprise Fund.

ADDITIONAL INFORMATION:

In 1999, the City became financially involved with the Greater Des Moines Partnership’s Choose Des Moines Communities with four \$100,000 annual contributions (FY2000 through FY2003). The City Council subsequently approved extending the agreement through FY2008 at a reduced annual rate of \$75,000. City Council also approved a reduction in the annual contribution from \$50,000 to \$37,500 for the Parking Amenities Program. During the extension agreement period, GDMP amended the contribution amount for FY2005 through FY2007 from \$75,000 to \$50,000 with FY2008 remaining at \$75,000. In FY09 GDMP initiated the Partnership 2012 Investment Campaign to assist Greater Des Moines Partnership programs that benefit Des Moines including Choose Des Moines Communities, Downtown Community Alliance, and Workforce Development and the City made it’s first payment of \$100,000 in 2010. This contribution will represent the City’s participation for the period July 1, 2010 through June 30, 2011 (FY2011).
