AGENDA HEADING:

Approving Change Order No. 21 with Corell Contractor, Inc. & Subsidiary for additional work on the Southeast Connector Paving – SW 2nd Street to SE 6th Street for a total not to exceed \$26,270.37.

SYNOPSIS:

Recommend approval of Change Order No. 21 in an amount not to exceed \$26,270.37 with Corell Contractor, Inc. & Subsidiary, Grant S. Corell, President, 1300 Lincoln Street, West Des Moines, IA, 50265, for additional work on the Southeast Connector Paving – SW 2nd Street to SE 6th Street to repair damaged pavement, sidewalk, traffic conduit, traffic loop detectors, and surface restoration on SE 4th Street caused by a winter 2010 water main break.

FISCAL IMPACT:

Amount: \$26,270.37

<u>Funding Source</u>: 2011-2012 CIP, Page Street Improvements-34, Southeast Connector – SW Second to SE Sixth Street, STR214, being funded 100% by Des Moines Water Works.

ADDITIONAL INFORMATION:

The contract for the construction of the Southeast Connector Paving – SW 2nd Street to SE 6th Street was awarded to Corell Contractor, Inc. & Subsidiary, in the amount of \$6,366,096.13. Part of this construction contract is to pave the section of SE 4th Street from the Southeast Connector to Scott Avenue. During the winter of 2010, Des Moines Water Works experienced a water main break in SE 4th Street south of the Southeast Connector. This water main break was on a section of original 6-inch water main. The excessive volume of water generated by this main break caused the undermining of various street and sidewalk panels, as well as filling numerous traffic signal conduit runs and handholes with silt. Two traffic signal detector loops were also damaged during the emergency repair of the water main. At the time of the water main break, temporary repairs were made to the pavement and the traffic signals in order to reopen SE 4th Street to traffic.

This change order includes all of the work necessary to make permanent repairs of the damage caused to SE 4th Street and surrounding area by the winter 2010 water main break. Since the damage was caused by Des Moines Water Works' main, they will reimburse 100% of the repair cost.
