

# **ADDITIONAL INFORMATION:**

This project provides for rehabilitation of the Easter Lake Bridge over a branch of Easter Lake. Recent bridge inspections determined that this 40 year old bridge is showing signs of deterioration, and the project will extend the service life of the bridge by twenty to thirty years. The project includes widening the existing structure to increase the roadway width and addition of a sidewalk/recreational trail.

This project requires partial fee acquisitions and temporary construction easements on property owned by Polk County on both sides of the Easter Lake Drive Bridge. Relocation assistance will not be required for this project. The project will be constructed in 2013 so as not to conflict with the widening of Indianola Avenue in 2012.
