## **AGENDA HEADING:**

Hearing on Public Works Supply Yard Storage Building: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Jensen Builders Ltd., Dale H. Jensen, President, \$596,600.

## SYNOPSIS:

This is a public hearing to allow for public input on the Public Works Supply Yard Storage Building and to take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. Due to the proposed SE Connector project and Kemin Industry's expansion, the Public Works Department is relocating its material supply yard. This project constructs a new storage building for Public Works equipment at their new material supply yard.

## **ADDITIONAL INFORMATION:**

On September 12, 2011, under Roll Call No. 11-1555, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Public Works Supply Yard Storage Building. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Public Works Supply Yard Storage Building, 10-2011-013. The improvement includes the construction of a new 8,750 square foot pre-engineered metal storage building including pavement removal, foundation, painting, glazing, mechanical, water main, fire sprinkler and electrical; all work in accordance with the contract documents including Plan File Nos. 537-77/95, at the Des Moines Public Works Supply Yard, 903 SE 22nd Street, Des Moines, Iowa.
