AGENDA HEADING:

Resolution establishing fair market value of various properties for the Grand Avenue over Walnut Creek Bridge Replacement Project.

SYNOPSIS:

Recommend approval of fair market values. This action establishes fair market value of property interests for the Grand Avenue over Walnut Creek Bridge Replacement Project. State law requires this action before the City can proceed with an offer to purchase the necessary property interests under the threat of eminent domain. These acquisitions will not require relocation assistance.

FISCAL IMPACT:

Amount: \$36,700 plus closing costs


<u>Funding Source</u>: 2011-12 CIP, Bridge and Viaduct Improvements, Grand Avenue over Walnut Creek, BRV045, Page Bridge/Viaduct Improvements – 12.

ADDITIONAL INFORMATION:

This project provides for the replacement of the structurally deficient and geometrically obsolete bridge on Grand Avenue over Walnut Creek with a new bridge. The recommended fair market values listed below are based on appraisals that were prepared and are being reviewed and approved by independent appraisers.

AA Des Moines, LLC is the owner of the commercial property at 6222 Grand Avenue, which has been appraised at \$21,800 for a partial fee acquisition, permanent easement for water main and temporary easement for construction. The property was constructed on a build-to-suit basis for Advanced Auto Parts which leases the property, so the appraiser allocated the compensation between the owner and the tenant. The landlord interest to AA Des Moines LLC is \$16,800 and the tenant interest to Advanced Auto Parts is \$5,000. This acquisition will not require relocation assistance.

Clear Channel Outdoor, Inc. is the owner of property located in the 6200 block of Grand Avenue improved with a billboard and associated site improvements. The property interests needed for the project have been appraised at \$14,900 for two partial fee acquisitions, a permanent easement for a recreational trail and a temporary easement for grading and retaining wall. This acquisition will not require relocation assistance.
