AGENDA HEADING:

Approving Professional Services Supplemental Agreement No. 2 with OPN, Inc. a/k/a OPN Architects, Inc. for design and construction phase services for Fire Department Training and Logistics Facility not to exceed \$46,000.

SYNOPSIS:

Recommend approval of the Professional Services Supplement Agreement No. 2 with OPN, Inc. a/k/a OPN Architects, Inc., Terry Gebard, Principal, 100 Court Avenue, Des Moines, Iowa, 50309, for professional services for the Fire Department Training and Logistics Facility for a lump sum amount of \$46,000, to provide additional design and construction phase services for fixtures, furniture and equipment (FFE).

ADDITIONAL INFORMATION:

The existing Fire Department furniture is beyond its life expectancy and is not ergonomically correct for computer work. New furnishings and equipment is needed for all areas of the new facility due to new spaces that did not exist before or were inadequately furnished for the programmed need.

At the time of the original agreement with OPN for design and construction administration services, the budget for fixtures, furnishing, and equipment (FFE) was not known. After the construction contract was awarded, the scope and budget for FFE was established. The scope of work includes specialized fixtures, furnishings and equipment for classrooms, break rooms, conference rooms, offices, warehousing, and maintenance areas, including items such as shelving, systems furniture, tables, chairs, file cabinets, projectors & screens, refrigerator, stove, ice machine, chain hoist trolley, welding curtain, compressor, hose reels, and interior signage.
