AGENDA HEADING:

Ordering construction of the following: SE Connector Demo & Site Prep - SE 9th St. to SE 15th St. - Receiving bids, (12-6-11), and Setting date of hearing, (12-19-11). (Construction Estimate - \$867,480).

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. Demolition, site clearance, and site prep for the future S.E. Connector Corridor between S.E. 9th Street and S.E. 15th Street.

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SE Connector Demo & Site Prep - SE 9th St. to SE 15th St., 25-2011-015. This improvement includes demolition, disconnection of utilities, site clearance, site prep, excavation, special backfill and placement of geogrid; all in accordance with the contract documents including Plan File Nos. 541 76/88, located in an area approximately from S.E. 9th Street to S.E. 15th Street and between Scott Avenue and the Burlington Northern Santa Fe Railroad, Des Moines, Iowa.

The estimated construction cost is \$867,480. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
