Approving the renewal of Cisco Smartnet maintenance contract with Pomeroy IT Solutions, Chris Froman, President, 11105 Aurora Ave, Urbandale, IA, 50322.

#### **SYNOPSIS:**

Recommend approval of a three-year contract with Pomeroy IT Solutions as low bidder for Cisco Smartnet maintenance contract. This will move the annual maintenance contract to a three-year contract, which will result in a total savings of \$53,939.04.

# **ADDITIONAL INFORMATION:**

The Cisco Smartnet maintenance covers \$1.3 million dollars of networking equipment located in various City buildings. This maintenance provides continuous updates to firewall protection, software upgrades and hardware replacement for equipment used to route data and voice traffic between all City departments. It is recommended that the City enter into a three-year agreement with three annual payments of \$167,460.86. By entering into a three-year agreement the City will save a total of \$53,939.04 over the next three years. Bids were requested for a single-year contract and a three-year contract with annual payments. By entering into a three-year contract, the current pricing can be locked in for the next three years and a savings of \$17,979.68 per year can be achieved.
