# **AGENDA HEADING:**

Public Hearing regarding the future issuance of general obligation bonds for the FY 2012-13 Capital Improvement Budget specifically for TIF projects.

## SYNOPSIS:

Public hearing regarding the future issuance of general obligation bonds for the FY 2012-13 Capital Improvement Budget specifically for TIF projects. This hearing will serve as authorization for the City Budget to include debt service payments on debt to be issued over the next several months. The amount of anticipated debt is drawn from the current Capital Improvement Program (CIP).

## FISCAL IMPACT:

<u>Amount</u>: Estimated \$14,230,000 of debt to be issued in spring 2012, with debt service payments in FY 2013 estimated at \$700,000.

Funding Source: Various TIF funds.

# **ADDITIONAL INFORMATION:**

In order to establish an accurate TIF budget for FY 2013, the City needs to approve the amount of new debt that will likely be issued in the spring of 2012. Holding a hearing on \$14,230,000 in TIF debt will allow the City to budget for the debt service payments associated with TIF projects approved in the current CIP. Final authorization to issue the debt will occur during the normal debt issuance process scheduled next spring. Changes to the CIP may also occur through the normal budgeting process which is underway. The timing of this hearing also allows for an accurate request for TIF certification procedures that must be completed by December 1, 2011.
