SYNOPSIS:

Recommend approval of the FFY 2011 Homeland Security Grant Program Agreements. The Iowa Homeland Security and Emergency Management Director has requested the City of Des Moines serve as the fiscal agent and authorized representative for the administration of Iowa's FFY 20112 Homeland Security Grant Program funds on behalf of Iowa's Explosive Ordinance Disposal (EOD) and Iowa's Weapons of Mass Destruction Tactical Officer's (SWAT) Task Force Programs.

FISCAL IMPACT:

<u>Amount</u>: \$252,000

<u>Funding Source</u>: Explosive Ordinance Disposal (EOD) Task Force (\$70,000) and Weapons of Mass Destruction Tactical Officer's (SWAT) (\$182,000), with the City of Des Moines to share in the receipt of purchased equipment with the other task force members. There is no local match required for the grants and U.S. Department of Homeland Security (DHS), Grant Programs Directorate, FFY 2011 Homeland Security Grant Program (HSGP) allocation made to the State of Iowa.
