AGENDA HEADING:

Approval of 2011 Project Safe Neighborhoods Anti-Gang Initiative Grant Award.

SYNOPSIS:

Recommend approval of accepting the 2011 Project Safe Neighborhoods Anti-Gang Initiative Grant Award. The Des Moines Police Department has been awarded to receive this grant through the U.S. Attorney’s Office for the Southern District of Iowa.

FISCAL IMPACT:

Amount: \$21,138 reimbursement grant. No matching funds required.

Funding Source: U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, 2011-2012 Operating Budget, Page 249-Special Revenue Funds, SP751, POL985207.

ADDITIONAL INFORMATION:

Project Safe Neighborhoods 2011 Anti-Gang Initiative provides funding to support new and expanded anti-gang prevention and enforcement efforts. The program is being administered through the State of Iowa Office of Drug Control Policy for the U.S. Department of Justice. The grant is for a two-year period from October 01, 2011 through September 30, 2013.

The grant provides reimbursable funds to the Des Moines Police Department to pay for officer overtime in expanded gang prevention initiatives throughout the city.
