### **AGENDA HEADING:**

Resolutions Approving Issuance of Certificate of Completion and Approving Issuance of Certificate of Termination for Neighborhood Development Corporation (NDC-McDonald's Project).

## **SYNOPSIS:**

By Roll Call 02-2354, dated September 23, 2002 City Council approved an Urban Renewal Development Agreement with Neighborhood Development Corporation for the development of a McDonald's (NDC-McDonald's Project) restaurant in the vicinity of 6th and University.

McDonalds Corporation has requested to exercise its option to purchase from NDC the land upon which the restaurant is constructed. To complete that sale, NDC is requesting that the City approve a certificate of completion and that the City approve termination of the Development Agreement and release of the urban renewal covenants that were a part of the development agreement.

Staff is recommending Council approve the Certificate of Completion and the Certificate of Termination.

#### **ADDITIONAL INFORMATION:**

In November 2003 the City issued a certificate of occupancy to NDC for a new one-story McDonalds Restaurant. The Developer, NDC, was to request a certificate of completion upon the completion of the restaurant, which it failed to do. NDC and McDonalds Corp have provided documentation that reflects the project is and has been in compliance with the Development Agreement and Urban Renewal Covenants since the completion of the development in 2003.
