Resolution Approving Issuance of Certificate of Completion for ST Investments, LLC (E5W Development Project).

SYNOPSIS:

On June 4th 2007, by Roll Call No. 07-1105, as amended on April 7, 2008, by Roll Call No. 08-583, the City Council approved an Urban Renewal Development Agreement with ST Investments, LLC for the redevelopment of parcels located at East Fifth and Walnut Street (E5W Development Project).

The Developer had completed E5W Project by June 30, 2009 in substantial compliance with the approved Conceptual Development Plan, but did not request until now that the City issue a Certificate of Completion as evidence of satisfaction of the Developer's construction obligations under the Development Agreement.

Staff is recommending approval of the issuance of the Certificate of Completion.

ADDITIONAL INFORMATION:

The 5-story building has floor plates varying from approximately 7,800 to 9,000 square feet. The first floor features four retail bays that may be combined if tenants desire larger space, portions presently leased to Village Bean and Baby Boomers Restaurant. The second floor consists of office space for up to four tenants. Thirty (30) for-sale condominiums will occupy the three upper floors. Nineteen (19) off-street, surface parking spaces are located on the east end of the site.
