# **AGENDA HEADING:**

Approving Change Order No. 7 with Cramer & Associates, Inc. for additional work on the S.W. 7th Street Bridge over Raccoon River and Trail Rehabilitation project, in an amount not to exceed \$229,993.96.

## SYNOPSIS:

Recommend approval of Change Order No. 7 in an amount not to exceed \$229,993.96 with Cramer & Associates, Inc., Robert Cramer, President/CAO, 3100 SW Brookside Drive, Grimes, IA 50111, for additional structural concrete, changeable message boards, concrete repair, deck underside, piers, rail, curb and sidewalk.

## FISCAL IMPACT:

<u>Funding Source</u>: 2011-2012 CIP, S.W. 7th Street Bridge over Raccoon River, BRV046, G.O. Bonds, Page Bridge-16.

# **ADDITIONAL INFORMATION:**

The contract for the rehabilitation of the S.W. 7th Street Bridge over Raccoon River and Trail project was awarded to Cramer & Associates, Inc., in the amount of \$1,433,246.20, which was under the original engineer's estimate of \$1,715,469. With final quantities and previous change orders, the total construction contract is \$2,032,248.33, of which \$1,000,000 is Federal Bridge Replacement and Rehabilitation funds.

The S.W. 7th Street Bridge over Raccoon River and Trail project was designed to restore the structural integrity to the bridge. During construction, the amount of deterioration was found to be more than had been estimated during the design of the project. This change order adjusts the estimated quantities for additional structural concrete, changeable message boards, concrete repair, deck underside, piers, rail, curb and sidewalk. The work on the substructure was, for the most part, done after the roadway was opened to traffic. This project was bid using the Iowa Department of Transportation (IDOT) specifications, which require field measurements of bridge repair items, because the quantities must be determined during removal operations. The cost of this change order, \$229,993.96, adjusts final contract quantities for these items to as-built quantities in accordance with the final accounting of the project.
