## AGENDA HEADING:

Approval of FY2010 Methamphetamine Drug Hot Spots Grant Program Revised Award from the Governor's Office of Drug Control Policy to include a new performance period.

## SYNOPSIS:

Recommend approval of the Des Moines Police Department's revised grant award from the Governor's Office of Drug Control Policy to be used for activities related to methamphetamine drug interdiction within the City of Des Moines.

## FISCAL IMPACT:

Amount: Additional \$18,424 for a total award of \$50,000. There is no match requirement for this grant.

Funding Source: U.S. Department of Justice through Iowa's Office of Drug Control Policy. Funds will be deposited in FY2012 Operating Budget, SP751, POL985015, Page 249.

## ADDITIONAL INFORMATION:

The Iowa Office of Drug Control Policy approached the Police Department regarding funding available to be directed towards activities related to methamphetamine drug interdiction within the City of Des Moines. The Police Department applied for and was initially awarded \$31,576. \$26,021 was allocated for overtime for the Vice and Narcotics Control Section working at various locations from July through December, 2011 performing activities related to interdiction of methamphetamine and other illegal drugs. Regular duty officers have been supplemented by officers working overtime in order to work the hours necessary to cause successful operations. \$5,555 was allocated for equipment to enhance the interdiction activities. The additional \$18,424 awarded will be directed towards overtime for interdiction activities primarily towards methamphetamine but including other illegal drugs and drug activity.

The grant period was from July 1, 2011 through December 31, 2011 and has been extended to June 30, 2012.
