AGENDA HEADING:

Award and approval of a 3.6% fee increase for G & S Service Inc., 4100 E 16th Street Des Moines IA 50313, Glen Mikel Owner.

SYNOPSIS:

The Des Moines Iowa Police Department requested the Finance Department Procurement Division to solicit bids for an agreement to furnish impounded vehicle towing and storage services for District 1 (West side) and District 2 (East side). Bids were received and the contract was awarded to G&S Services Inc., 4100 E 16th Street, Des Moines, IA 50313 during the November 9, 2009 council meeting Roll Call number 09-2066. The term of the contract is thirty-six months with the option of two additional twelve month periods. A provision stated in the contract allows G&S Services to request an increase in fees after the first two years are completed.

The second year of the contract expired December 26, 2011. G & S Services has requested the allowable increase in fees at a rate of 3.6% which equals the current Federal Cost of Living Adjustment. The Police Department accepts this percentage of increase and agrees to pay the increased fee requested by G&S Services.

ADDITIONAL INFORMATION:

At the November 9, 2010 Council meeting, Council approved the city wide towing contract with G&S Services, Incorporated. This contract included an option for the contractor to request an increase in fees at the end of the first two years of the contract. The first two year of the contract expired December 26, 2011. The Police Department reviewed the service received from G&S Services and found the service has been acceptable with minimal complaints from the citizens of Des Moines. The Police Department would like to allow a 3.6% increase in the monetary value of the fees paid to G&S Services. This percentage is based on a federal standard cost of living increase which is within the tolerance of the contracted amount.
