AGENDA HEADING:

Approving Supplemental Agreement No. 2 to the Des Moines River Regional Trail – Phase 1 Professional Services Agreement with AECOM Technical Services, Inc. to provide construction phase services, not to exceed \$83,300.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 2 to the Professional Services Agreement with AECOM Technical Services, Inc., Steven J. Eaton, Principal-in-Charge, 500 S.W. 7th Street, Suite 301, Des Moines, Iowa, 50309, for a total cost not to exceed \$83,300, based on hourly rates to provide construction phase services for Des Moines River Regional Trail – Phase 1.

ADDITIONAL INFORMATION:

Supplemental Agreement No. 2 includes construction phase services required for construction of the Des Moines River Regional Trail – Phase 1. The Des Moines River Regional Trail - Phase 1 connects the existing trails near Principal Park at the confluence of the Des Moines and Raccoon Rivers to near the James W. Cownie Baseball Park at SE 22nd Street and Hartford Avenue. Construction phase services in this supplemental agreement include construction administration and coordination. On-site observation and materials testing will be performed by City staff. The work will include administration required to satisfy City of Des Moines and Iowa Department of Transportation (IDOT) requirements.

On May 18, 2009, by Roll Call No. 09-822, City Council approved the professional services agreement that included design for a cost not to exceed \$202,000. AECOM Technical Services, Inc. was selected by a committee composed of representatives from the Parks and Recreation and Engineering department. Twelve proposals were received in response to the Request for Proposals (RFP). AECOM Technical Services, Inc. has prepared the construction plans in accordance with IDOT requirements and is the most appropriate consulting firm to provide construction phase services.
