AGENDA HEADING:

Resolution approving application to the Iowa Economic Development Authority for Enterprise Zone benefits for the Neighborhood Development Corporation housing project in the River South Enterprise Zone

SYNOPSIS:

Neighborhood Development Corporation has presented application for State of Iowa Enterprise Zone benefits for a housing project at 1938 SE 6th Street. The \$1.5 million project proposes construction of 11 residential units. Neighborhood Development Corporation is a non-profit community organization that is engaged in the revitalization of distressed neighborhoods through new construction and building rehabilitation projects. The NDC project at 1938 SE 6th will provide quality infill development and create an affordable housing option in the River South Enterprise Zone.

FISCAL IMPACT:

Amount: Investment Tax Credit: \$148,637; Sales Tax Rebate: \$89,182

<u>Funding Source</u>: State of Iowa Enterprise Zone program. These are State of Iowa tax credits and have no fiscal impact on the City of Des Moines.

ADDITIONAL INFORMATION:

Neighborhood Development Corporation is undertaking the redevelopment of a site on SE 6th Street that formerly held vacant and blighted buildings, contributing little value to the surrounding neighborhood. NDC's intentions are to create opportunities for housing, business and employment for neighborhood residents by investing in this site. Historically, properties that have undergone redevelopment by NDC have successfully increased property values and added significant improvements to the neighborhoods they are located in.

The project is scheduled to begin construction in spring 2012, and be completed by spring 2014.
